# Local Government Reorganisation

- Local Government Reorganisation is the process in which the structure and responsibilities of local authorities are reconfigured.
- The Government has set out plans to move away from the current two-tier system of district and county councils.
- For most areas this means new councils with a population of 500,000 or more. Decisions will be made case by case.

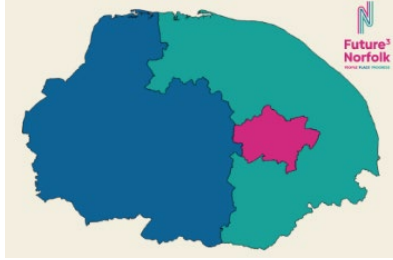
## Devolution vs Local Government Reorganisation:

While devolution focuses on giving local authorities more power, local government reorganisation changes how councils are structured, often merging them or creating new units.

### Timelines:

- Final proposal submissions – 25th September 2025
- Consultation – November 2025 to January 2026
- Decision Announcement – March 2026
- Secondary Legislation – Autumn 2026
- Election to new unitaries – May 2027
- New authorities operational – 1 April 2028

# Local Government Reorganisation



**Proposal 1** – All districts except for South Norfolk District Council and Norfolk County Council support this proposal of three new unitaries. They are Future Norfolk3. This would consist of East and West Norfolk and Greater Norwich.



**Proposal 2** – Norfolk County Council – One Norfolk and One Council.



**Proposal 1** - advocates for a One Suffolk.



**Proposal 2** - The other proposes three councils Western Suffolk, Central and Eastern Suffolk and Ipswich and Southern Suffolk.



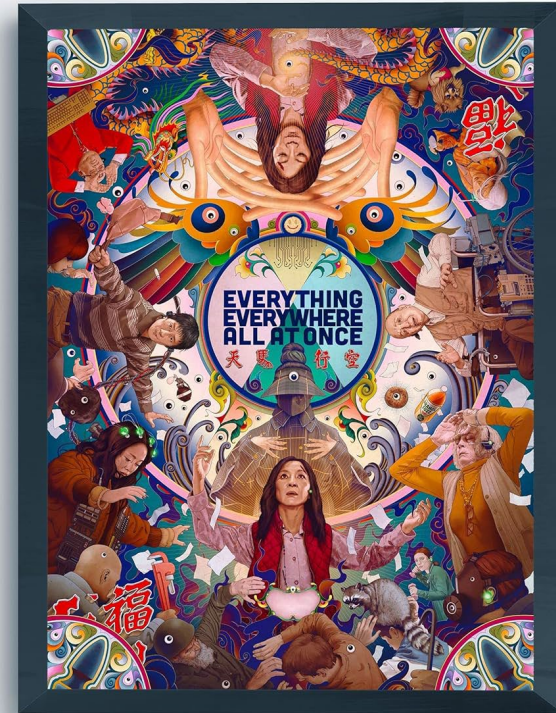
**Proposal 3** –The plan outlines the creation of two new unitary authorities: Norwich & East Norfolk and West & North Norfolk.

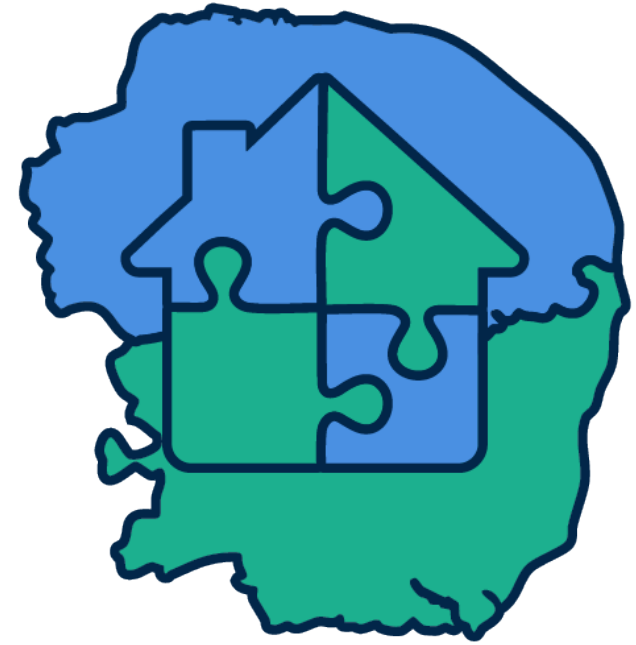
# Norfolk and Suffolk Housing Partnership (N&SHP)

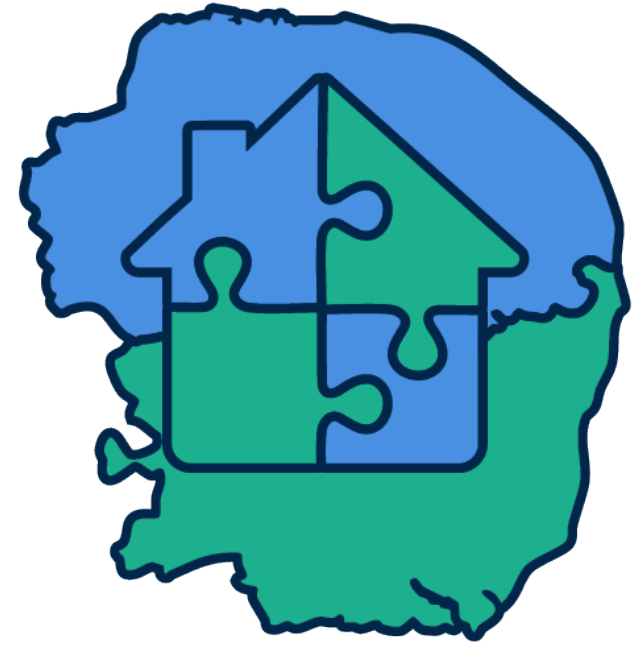
